

## MINUTES OF THE ANNUAL MEETING OF THE BOARD OF DIRECTORS

## HACHISAKURA JUDO CLUB INC A Non-Profit Recreational Organization

Pursuant to notice, an annual meeting of the Board of Directors of HachiSakura Judo Club Inc was held on 06 January 2020 at 10:00 AM at the corporation's place of business.

I. **QUORUM**. A quorum was declared present based on the presence of the following Directors: Jack M Varcados

The following corporate actions were taken by appropriate motions duly made and adopted by vote of the Executive Director.

- II. **APPROVE PREVIOUS MINUTES**. The minutes of the annual meeting held on 07 January 2019, were approved.
- III. REPORTS.
  - Memberships, Promotions, and Class Attendance Report
- IV. ADOPTION OF DOCUMENTS/PLANS.

No new Bylaw Amendments were introduced.

- V. **ADOPTION OF NEW CORPORATE/CLUB LOGO**. The original logo developed by Jack M Varcados has been realized to be too *busy*. The complexity of the image along with the multiple colors of the entire logo make the image unusable/unaffordable for practical applications. Shrinking and enlarging the image for various use makes the image blurry and pixilated. The multiple colors drastically increase the cost of marketing products. Therefore, a new, two-color, simplified logo has been created and will be used instead.
- VI. PLANS TO CHANGE CLUB AFFILIATION. USJA individual memberships (\$60 per year) and club memberships (\$35 per year) have gradually increased, and while USJA costs are lower than USJF or USA Judo, there is still a less expensive option. AAU Judo provides better liability insurance for individuals and for clubs. Extended coverage for youth is \$18 per year; extended coverage for adults is \$39 per year; club memberships start at \$30 per year. Therefore, HSJC will change national club affiliation to AAU Judo beginning January 2020 and will gradually phase/change individual memberships to AAU Judo as current USJA memberships expire during the year. By the end of 2020, all individual memberships will be changed over to AAU Judo.
- VII. **APPROVAL OF OTHER ACTIONS SECTION**. The actions and undertakings of the Executive Director, Officers, and Agents of the corporation were approved with respect to: All other actions subsequent to the last annual meeting of the Board of Directors.
- VIII. **FINANCIAL STATEMENTS PRESENTATION**. The financial statements for the fiscal year ending 31 December 2019, as prepared by the Executive Director, were approved.
